### Variation to Registry Manager Market Operator Service Provider Agreement

I refer to the Registry Manager Market Operator Service Provider Agreement (MOSPA) between the Electricity Authority (Authority) and Jade Software Corporation (NZ) Limited, dated 25 January 2017, relating to services provided by Jade Software Corporation (NZ) Limited as the registry manager.

The Authority would like to vary the functional specification in Schedule 3 of the MOSPA, as follows:

- Update to SD-010 (CR-1270) NSP Table Mapping:
  - Allow an inferred delete to be accepted whether the NSP entry start date is historic or not
- Update to Process Maps, Web Services, SI-010, SI-020, NP-080, PR-370, QU-020, RS-010, RW-020, RM-020, MM-010, SD-020, Batch interface cross reference map (CR-1208) EIEP5A Registry Format:
  - Addition of the EIEP5A format and Registry distribution of planned service interruption.
- Minor updates to EI-030 and RS-010:
  - States the EIEP outbox is cleared of files more than 30 days old, changed to EIEP inbox
  - prevent the reversal of distributor updates when the result of the reversal will change the responsible distributor in the registry.

A copy of the functional specification with these proposed variations incorporated is attached to this letter. If you agree to it, the varied functional specification will become version 22.39 in Schedule 3 of the MOSPA.

Please confirm your acceptance of the variations proposed in this letter by signing and returning a copy of this letter to me. These proposed variations to the MOSPA will take effect on the date you sign this letter.
