## Amendment to Registry Manager Market Operator Service Provider Agreement

I refer to the Registry Manager Market Operator Service Provider Agreement (MOSPA) between the Electricity Authority (Authority) and Jade Software Corporation (NZ) Limited, dated 25 January 2017, relating to services provided by Jade Software Corporation (NZ) Limited as the registry manager.

The Authority agrees to amend the MOSPA by (specific change shown in yellow):

- 1) replacing clause 3 of Schedule 1 (version 1.6) of the MOSPA with the following:
