We are issuing a new comprehensive and ongoing information gathering request to retailers using our powers under the Code and expect to start receiving and publishing data in the second half of this year. Mandatory monthly reporting will reduce the number of individual requests we need to make.

Purpose	The working paper tests the scope and focus of Task Force initiative to consider requiring gentailers to offer long-term firming for Power Purchase Agreements (PPAs) (initiative 1A), which is premised on the potential for PPAs to support business models that would intensify competition to build new generation and sell electricity. The working paper is a key input into developing and evaluating options for consultation in April 2025.
