It has one less column than other ICP's.</p> <p>The issue relates to a series of status updates occurring in 2019 where ultimately the ICP was decommissioned, the final decommission appeared to have been the cause however a replication of the updates was unable to produce the same result.</p> <p>The ICP's intermediate reporting data was rebuilt which resolved the issue</p>	Complete
