1. Introduction

- 1.1.1 The Market Development Advisory Group (MDAG) was formed by the Electricity Authority (Authority) in October 2017. The MDAG provides independent advice to the Authority on the development of the Electricity Industry Participation Code 2010 and market facilitation measures.
- 1.1.2 The MDAG focuses its advice on matters relating to the evolution of the 'machinery' of the electricity market. Specifically, under its <u>terms of reference</u> the MDAG can advise on:
 - a) initiatives to promote efficient pricing in markets and for monopoly services
 - b) initiatives to promote efficient management of capacity and energy risks
 - c) any other policy matters that the Authority considers appropriate.
- 1.1.3 The MDAG's terms of reference require the Chair to report annually to the Authority Board on the MDAG's progress against its work plan. This is the MDAG's third annual report, covering its activities from July 2019 to June 2020 (reporting period).
- 1.1.4 The two projects on the MDAG's work plan in the reporting period were *Review* of spot market trading conduct provisions, and *Participation of new generating* technologies in the wholesale market.

3. Work plan overview

3.1 Review of spot market trading conduct provisions

- 3.1.1 In February 2019, MDAG published an updated and more comprehensive slide pack on problem definition and possible options. In addition, analysis was undertaken for MDAG by Concept Consulting on various issues relating to trading conduct, and further advice was obtained from Bell Gully.
- 3.1.2 A briefing pack was published in June 2019, achieving the 2018/19 Authority work programme milestone, inviting market participants to attend a Briefing and Discussion on 30 July 2019.
- 3.1.3 Table 4 sets out the MDAG's progress on the project in the reporting period.

3.2 Participation of new generating technologies in the wholesale market

The Authority first asked MDAG to consider undertaking this project in February 2019. MDAG made recommendations to the Authority following a thorough investigative process working closely with Authority staff. MDAG recommended that the Authority set up a medium to long term project to undertake a fundamental review of the Code against a set of principles, including the principle of competitive neutrality across different technologies, and that the Authority utilise MDAG as a sounding board on particular elements of that project as and when appropriate.
