**Amendment to Registry Manager Market Operator Service Provider Agreement**

I refer to the Registry Manager Market Operator Service Provider Agreement (MOSPA) between the Electricity Authority (Authority) and Jade Software Corporation (NZ) Limited, dated 25 January 2017, relating to services provided by Jade Software Corporation (NZ) Limited as the registry manager.

The Authority would like to amend the MOSPA by:

1) replacing clause 2.1 of Schedule 1 (version 1.7) of the MOSPA with the following:

2.1. The monthly fee is as follows (the "**Monthly Fee**"):

- 2) replacing the 'Disk' row of Table 2 in clause 5 of Schedule 1 (version 1.4) of the MOSPA with the following:

If you agree to it, this amendment will allow for the increase of disk capacity to cater for forecast storage requirements until 1 July 2026.

The amended Schedule 1 of the MOSPA will become version 1.8.
