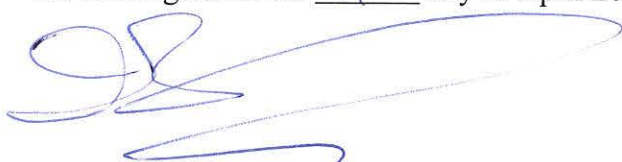

Amendment

1 Title

This is the Electricity Industry Participation (Minor Code Amendments) Code Amendment 2014.

2 Commencement

This amendment comes into force on 15 May 2014.

3 Code amended

This amendment amends the Electricity Industry Participation Code 2010.

4 Clause 1.1 amended (Interpretation)

- (1) In clause 1.1(1), definition of "**constraint price**",—
 - (a) after "**MW**", insert "per hour"; and
 - (b) replace "decreased" with "increased".
- (2) In clause 1.1(1), revoke the definition of "**data logger**".
- (3) In clause 1.1(1), definition of "**offer**", replace "13.17 and" with "13.17 to".
- (4) In clause 1.1(1), definition of "**participant identifier**", after "identify the **participant**" insert ", including".

- (5) In clause 1.1(1), definition of "**risk management contract**", replace paragraph (c) with:
 "(c) an **options contract**; but
 "(d) does not include an **FTR**".
- (6) In clause 1.1(1), definition of "**special protection scheme**",—
 (a) replace "take" with "takes"; and
 (b) replace "demand" with "**demand**".
- (7) In clause 1.1(1),—
 (a) revoke the definition of "**transmission alternative**"; and
 (b) insert in its appropriate alphabetical order:
 "**transmission alternative** means an alternative to investment in the **grid**, including investment in local generation, energy efficiency, demand-side management and **distribution network** augmentation set out in Part 12".

5 Clause 5.1A amended (Time limit for investigating undesirable trading situation)

Amend clause 5.1A as follows:

- (a) after "investigation if", insert "more than";
- (b) after "**business days**", delete "or more".

6 Clause 7.11 amended (Review of performance of the system operator)

In clause 7.11(4), delete "the meeting of" and "at which it".

7 Clause 8.31 amended (Grant of dispensations)

Amend clause 8.31 as follows:

- (a) in subclause (1), replace "**assets**, if" with "**assets**, but";
- (b) in subclause (1)(a), replace "the approval" with "if the approval";
- (c) in subclause (1)(b), replace "acknowledges" with "must acknowledge";
- (d) in subclause (1)(c):
 - (i) replace "for the purpose of" with "if the **dispensation** is"; and
 - (ii) replace "a **generator** is" with "the **generator** must be".

8 Clause 8.32 amended (Liability of asset owner pending decision)

In clause 8.32, replace "**equivalence arrangement or dispensation**" with "non-compliance".

9 Clause 8.37 amended (Other provisions relating to equivalence arrangements and dispensations)

After clause 8.37(1), insert:

"(1A) An **asset owner** who is granted a **dispensation** must comply with its obligations under that **dispensation**".

10 Clause 8.67 amended (Voltage support costs allocated in 3 parts – nominated peak, monthly peak and residual charges)

In clause 8.67(5), after " $\text{Residual}_{\text{ALLZ}} = V \text{ cost}_z - \text{Nom Charge}_{\text{ALLZ}}$ ", insert "-".

11 Schedule 8.3, Technical Code A, clause 4 amended

In the heading to Schedule 8.3, Technical Code A, clause 4, delete "the" and "a".

- 12 Schedule 8.3, Technical Code B, clause 4 amended**
In Schedule 8.3, Technical Code B, clause 4, replace "operator" with "**operator**".
- 13 Clause 10.46 amended (Statement of situation)**
Replace clause 10.46(2) with:
"(2) A **metering equipment provider** must, within 3 **business days** of receiving the statement of situation, provide copies of it—
"(a) to the relevant affected **participants** for all **metering installations**; and
"(b) to the **market administrator**—
"(i) for all category 3 and above **metering installations**; and
"(ii) if requested by the **market administrator**, for each **category 1 metering installation** and each **category 2 metering installation**".
- 14 Schedule 10.1, Table 3 amended**
Amend Schedule 10.1, Table 3 as follows:
(a) in column 1, row 6, replace "loggers" with "storage devices";

Amend Schedule 10.2, clause 9 as follows:
(a) replace "a" with "the";
(b) replace ", including any responses from the **relevant participant**" with "required under clause 2(f)(iii)".
- 18 Schedule 10.7, clause 11 amended**
In Schedule 10.7, clause 11(3)(b), replace "a test laboratory" with "an **approved test laboratory** or an **approved calibration laboratory**".
- 19 Schedule 10.7, clause 31 amended**
In Schedule 10.7, clause 31(7)(b), after "confirm that", insert "a **class A ATH** or".
- 20 Schedule 10.8, clause 4 amended**
In Schedule 10.8, clause 4(1)(b), replace "subparagraph (i)" with "paragraph (a)".
- 21 Clause 11.15C amended (Process for retailer events of default)**
In clause 11.15C(2), replace "participant" with "**participant**".
- 22 Clause 11.18 amended (Trader responsibility for ICP)**
Amend clause 11.18(5) as follows:

- (a) replace "**trade**" with "trade";
- (b) after "for the **ICP**", insert ", unless the **trader** trades only **unmetered load** at that **ICP**".

23 Schedule 11.1, clause 7 amended

Amend Schedule 11.1, clause 7 as follows:

- (a) in subclause (1), replace "network" with "**network**";
- (b) in subclause (1)(b), replace "subclauses (4) and (5)" with "subclause (4)";
- (c) replace subclause (1)(h) with:
 - "(h) if the **price category** code assigned under paragraph (g) requires a value for the capacity of the **ICP**, the **chargeable capacity** of the **ICP**, as follows:
 - "(i) if the **chargeable capacity** cannot be determined before **electricity** is traded at the **ICP**, a placeholder **chargeable capacity**;
 - "(ii) if the capacity value can be determined from the **metering information**, no **chargeable capacity**;
 - "(iii) in any other case, the actual **chargeable capacity**:".

24 Schedule 11.1, clause 9 amended

In Schedule 11.1, clause 9(1), delete paragraph (e).

25 Schedule 11.1, clause 14 amended

In Schedule 11.1, clause 14(1)(a), replace "and" with "or".

26 Schedule 11.1, clause 15 replaced

In Schedule 11.1, replace clause 15 with:

"15 "New" or "Ready" status for 24 calendar months or more

- "(1) Subclause (2) applies if—
 - "(a) an **ICP** has had the status of "New" for 24 calendar months or more; or
 - "(b) an **ICP** has had the status of "Ready" for 24 calendar months or more.
- "(2) The **distributor** must—
 - "(a) ask the **trader** who intends to trade at the **ICP** whether the **ICP** should continue to have that status; and
 - "(b) decommission the **ICP** if the **trader** advises that the **ICP** should not continue to have that status."

 - "(a) the applicant **distributor** has complied with clauses 2, 3 and 5; and

- "(b) the **market administrator** considers that it has not been materially disadvantaged by the applicant **distributor's** failure to comply with clause 4."

This definition is subject to clause 34 of this **transmission pricing methodology** and any prudent discount agreement".

- "(6) Despite subclause (4), the **Authority** may **publicise** the **EIEPs** described as EIEP1, EIEP2 and EIEP3 under this clause, despite the **Authority** having

consulted with **participants** that the **Authority** considers likely to be affected by those EIEPs, before this clause came into force."

"(db) the **clearing manager** calculates **constrained off amounts** and **constrained on amounts**; and";

In clause 13.38(3), after "subclause (1)", insert ", by an **ancillary service agent** that is a **generator**".

In clause 13.39, after "Accordingly, an **ancillary service agent**", insert "that is a **generator**".

40 Clause 13.44 amended (How quantity is to be specified in reserve offers)

Amend clause 13.44 as follows:

(a) replace "in 6 seconds" with "as **fast instantaneous reserves**";

(b) replace "60 seconds" with "**sustained instantaneous reserves**".

41 Clause 13.47 amended (Quantity changes may be made within 2 hours before trading period)

In clause 13.47(2), after "submission", delete ", ".

42 Clause 13.53 amended (Additional information to be provided by participants)

Amend clause 13.53 as follows:

(a) after "**reserve offer**", insert "for **partly loaded spinning reserve** or **tail water depressed reserve**";

(b) after "**partly loaded spinning reserve**", replace "and" with "or".

43 Clause 13.60 amended (Block dispatch may occur)

After clause 13.60(2), insert:

"(3) The **generator** must notify the **system operator** and the **clearing manager** of any change to an agreement for **block dispatch** made under this clause or clause 13.61 at least 5 **business days** before the change takes effect."

44 Clause 13.61 amended (System operator to notify block security constraints)

In clause 13.61, revoke subclause (3).

45 Clause 13.76 amended (Dispatch instructions to be logged)

In clause 13.76(6), replace "(4)" with "(5)".

46 Clause 13.80 amended (Dispatch instructions provided to grid owner)

In clause 13.80(1), replace "electricity" with "active power".

47 Clause 13.81 amended (Backup procedures if communication not possible)

In clause 13.81(b), after "generator", insert "or ancillary service agent".

48 Clause 13.90 amended (Process for publishing real time prices)

Replace clause 13.90(1)(b)(ii) with:

"(ii) the number of groups of transmission lines or transformers, or both, that have a total MW arc flow equal to the relevant maximum flow limit (in MW) as set by the system operator in accordance with Schedule 13.3:".

49 Clause 13.194 amended (Clearing manager to calculate constrained off amounts)

In clause 13.194(2)(c), replace "frequency keeping" with "frequency keeping".

50 Schedule 13.1, Form 5 amended

Amend Schedule 13.1, Form 5 as follows:

- (a) replace "Fast Response" with "Fast Instantaneous Reserve" in each place:
- (b) replace "Sustained Response" with "Sustained Instantaneous Reserve" in each place.

51 Schedule 13.1, Form 6 amended

Amend Schedule 13.1, Form 6 as follows:

- (a) replace "Fast Response" with "Fast Instantaneous Reserve" in each place:
- (b) replace "Sustained Response" with "Sustained Instantaneous Reserve" in each place.

52 Schedule 13.1, Form 7 amended

Amend Schedule 13.1, Form 7 as follows:

- (a) replace "Fast Response Reserve" with "Fast Instantaneous Reserve" in each place:
- (b) replace "Sustained Response Reserve" with "Sustained Instantaneous Reserve" in each place.

Amend Schedule 13.1, Form 9, question 2 as follows:

- (a) replace "caused by a rule" with "caused by a Code":
- (b) replace "specify the rule" with "specify the clause".

In clause 15.33, replace "publish" with "**publish**".

61 New cross heading inserted

Above clause 15.38, insert the cross heading "*Certification*".

62 Clause 15.38 amended (Functions requiring certification)

After clause 15.38(1A), insert:

"(1B) For the purposes of subclause (1A), each reference to a **reconciliation participant** in Schedule 15.1 is to be read as a reference to a **dispatchable load purchaser**".

63 New cross heading inserted

Above clause 15.39, insert the cross heading "*Participant identifiers*".

64 Schedule 15.1, clause 8A amended

In Schedule 15.1, clause 8A(3), replace "certification" with "**certification**".

Explanatory Note

This note is not part of the Code amendment, but is intended to indicate its general effect.

The amendment makes various minor amendments to the Electricity Industry Participation Code 2010 ("Code") including:

- (a) adding bold to defined terms, or removing bold from terms that are not defined;
- (b) placing defined terms into the correct alphabetical order;
- (c) removing unnecessary words;
- (d) correcting clause headings and contents clauses;
- (e) correcting wording where the context is clear that the wrong wording has been used; and
- (f) reducing minor obligations on participants.

This amendment to the Electricity Industry Participation Code 2010 comes into force on 15 May 2014.
